

**CUMBERLAND COUNTY IMPROVEMENT AUTHORITY
NOTICE OF PUBLIC HEARING**

The Cumberland County Improvement Authority (the "Authority") will hold a public hearing on **August 26, 2020 at 4:00 p.m.** for the purpose of providing a reasonable opportunity for interested persons to express their views both orally and in writing with respect to the proposed issuance by the Authority of one or more series of Charter School Revenue Bonds, the interest on which is expected to be excluded from gross income for purposes of federal income taxation (the "Bonds"), in the maximum aggregate face amount not to exceed \$9,000,000. The proceeds from the sale of the Bonds will be loaned to The Friends of Millville Public Charter School a NJ Nonprofit Corporation (the "Borrower") and used to finance: (i) the refinancing of the acquisition and renovation of the school facilities located at 1101 Wheaton Avenue, Millville, New Jersey (the "School Facilities"); (ii) the undertaking of capital improvements at the School Facilities, including upgrading HVAC systems; (iii) the funding of deposits to a debt service reserve fund; and (iv) the paying all or any portion of the issuance costs related to such Bond issue (collectively, the "Project"). The School Facilities will be owned by Borrower and leased to Millville Public Charter School A NJ Nonprofit Corporation for use in its operation of a public charter school therein.
